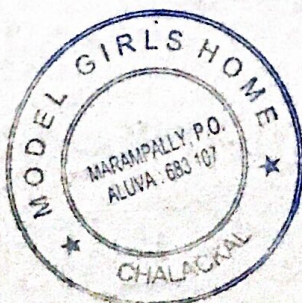




1. Condition "As Is". Donor is not making any representations, warranties, or guarantees about the Donated Equipment, including any implied warranties of merchantability and/or fitness for any purpose. Recipient accepts the Donated Equipment "as is." Recipient understands that Donor will not provide any instructions or follow-up services, replacement parts, or repairs.
2. The donated equipment has been arranged by the Donor to help institutions that has been affected by the Kerala floods 2018. The recipient assures that the donated equipment will be used to replace the equipment lost during the floods and will not be put to any personal use by the Recipient, its officers, agents and employees.
3. Assumption of Risk. Recipient assumes full responsibility for all risks arising directly or indirectly from the possession, use or misuse of the Donated Equipment, both known and unknown, regardless of the cause.
4. Waiver and Release. Recipient waives and releases any and all claims against Donor, its officers, agents and employees (collectively "Donor Parties") with respect to any and all loss or damage to property resulting from possession, use or misuse of the Donated Equipment, regardless of the cause and even if caused by negligence, whether passive or active. Recipient agrees not to sue any of the Donor Parties on the basis of these waived and released claims.
5. Indemnity. Recipient will defend, indemnify and hold the Donor Parties harmless from and against any and all liability, loss, damages, claims and attorney's fees that may be suffered by any Recipient Party resulting directly or indirectly from the possession, use or misuse of the Donated Equipment by Recipient or any other person.


